ACCEPTANCE OF LETTER OF AWARD BY DAPAT VISTA (M) SDN. BHD., A SUBSIDIARY OF THE COMPANY PERTAINING TO THE PROVISION OF ONLINE DIGITAL ID ONBOARDING REGISTRATION SERVICES

1. Introduction

The Board of Directors ("**Board**") of Pertama wishes to announce that DAPAT Vista (M) Sdn. Bhd. ("**DAPAT**" or "**Contractor**"), a subsidiary of the Company had on 2 July 2024 accepted a Letter of Award ("**LOA**") awarded by My Digital ID Sdn. Bhd. ("**My Digital ID**") [Company Registration No.: 202401002053 (1547903-K)] dated 28 June 2024 for the provision of online digital ID onboarding registration services ("**Contract**").

2. Information on My Digital ID

My Digital ID is incorporated in Malaysia with its business office at MRANTI Technology Park, Bukit Jalil, 57000 Kuala Lumpur and is principally involved in information technology service activities N.E.C. and information communication technology (ICT) system security.

3. Duration and Terms of the Contract

DAPAT must provide public online onboarding services for My Digital ID and ensure that the services are available and operational 24 hours a day. DAPAT is responsible and accountable for user support and the continuous availability of the service.

The duration of the Contract for the above provision is for a period of four (4) months ("**Primary Term**"), with an option to extend the Contract for an additional three (3) months ("**Secondary Term**").

Should My Digital ID wish to extend the Contract after the expiry of the Primary Term, a letter of Intent ("**LOI**") will be issued to DAPAT. The LOI will be issued within one (1) month prior to the expiry of the Primary Term. Thereafter, MIMOS and DAPAT will enter into negotiations to review the scope of services, prices/rates, and terms and conditions before extending the Contract for the Secondary Term.

During the term of the Contract, MY Digital ID reserves its absolute right to terminate the Contract prior to its expiry date. This shall be carried out through the issuance of a one (1) month's notice of termination to DAPAT by My Digital ID Procurement Department.

Upon completion of the service, DAPAT shall complete the Certificate of Completion and seek approval from My Digital ID's authorised personnel.

4. Risk Factors of the LOA

The Company does not expect any material risk arising from the LOA other than the normal operational risk associated with the LOA.

5. Financial Effects

The LOA will not have any effect on the share capital and substantial shareholders' shareholdings of the Company. However, the LOA is expected to contribute positively to the future earnings of the Group and strengthen the net assets position of the Group over the duration of the Contract.

6. Interest of Directors, Major Shareholders, and/or Persons connected with them

None of the Directors and/or major shareholders of the Company and/or persons connected with them has any direct or indirect interest in the LOA.

7. Directors' Statement

The Board of Pertama, having considered all aspects of the LOA, is of the opinion that the execution of the acceptance of LOA is in the best interest of the Company.
