eJamin **Advancing Due Process**



The Quick Fix:

eJamin was designed to reduce the time it takes to post bail from three hours to just fifteen minutes. It eliminated courthouse queues, manual paperwork, and the need for physical cash payments. With a few taps, justice became more accessible.

The Lasting Change:

From a functional fix, eJamin became a judicial infrastructure upgrade. It is now embedded in 192 courts across Malaysia, with over RM1 billion in bail transactions processed.

Its next phase involves integration with Syariah courts and the development of AI-powered legal tools - creating a fairer, faster, and more inclusive legal system.

KOCEK Revitalising Currency Circulation



The Quick Fix:


KOCEK was created to solve a simple but widespread problem what to do with the piles of forgotten, unused coins sitting idle in Malaysian homes. By converting these coins into instant digital credit, KOCEK gave people a seamless way to reclaim value, turning physical sen into spendable funds.

The Lasting Change:

KOCEK has evolved into a full ecosystem.

KOCEK OUT, already in operation, enables merchants and small businesses to purchase coins on demand - ensuring smoother retail transactions and maintaining liquidity for cash-heavy trades.

The next phase is KOCEK Pintar, a school-based initiative designed to empower children with digital savings habits, financial literacy, and access to cashless spending for meals and essentials, in partnership with PINTAR Foundation and a local bank. Together, these efforts support Bank Negara Malaysia's coin circulation agenda and build financial inclusivity from childhood through adulthood.



The Quick Fix:

BizKecil is being developed as a one-stop mobile solution tailored for Malaysia's petty traders and microentrepreneurs. At launch, it will provide essential business tools such as inventory tracking, digital payments, and simplified access to financing addressing everyday operational gaps for the informal sector.

The Lasting Change:

Beyond streamlining daily transactions, **BizKecil** is envisioned as a long-term bridge between the informal economy and the financial system.

Designed in collaboration with national small trader associations and a local bank partner, it aims to formalise economic activity, unlock financial products, and uplift underserved communities.

With an initial target reach of 450,000 traders, BizKecil lays the groundwork for inclusive economic participation, social protection, and a more resilient microenterprise landscape.
